## **Important Information Regarding Notice of Pregnancy Submission**

MO HealthNet partnered with all three managed care plans to implement a standardized process for completing and submitting Notification of Pregnancy (NOP) forms. As of November 1, 2024. MO HealthNet enrolled providers who provide obstetric care/services, primary care, and emergency care, can submit a participant's NOP and Risk Screening in one easy step through the new NOP and Risk Screening Portal. Upon submission in the new NOP and Risk Screening Portal, you will receive a confirmation of the submission. This information will then be sent to Home State Health. Our care management team will outreach to all members identified through the NOP portal and will offer care management services, review benefits, and explore opportunities to support the member. This new NOP and Risk Screening process is intended to not only notify the health plan of the participant's pregnancy, but also of the participant's Social Determinants of Health (SDOH) factors to ensure support can be provided to participants as early as possible.

The NOP and Risk Screening Portal should be completed during all initial encounters during which the pregnancy is diagnosed and/or confirmed. Effective January 1, 2024, all providers will be required to submit NOPs via the NOP and Risk Screening Portal:

Pregnancy Notification The new NOP and Risk Screening Form will replace Home State's NOP form and providers will no longer be able to submit NOPs through our provider portal or via fax.
