Important Revision to Previous Information Regarding Sleep Study Authorization Changes

The Effective date for this process has changed to **February 1, 2025**, not January 1, 2025, as previously stated. Beginning February 1, 2025, sleep study authorizations should be submitted directly to Home State Health. Turning Point will no longer be managing Home State Health authorizations for sleep studies.

Below are additional changes to sleep study prior authorization requirements beginning February 1, 2025.

The following codes will no longer require prior authorization:

Unattended/Home Sleep Studies:

- G0398: Home Sleep Test, Type II Portable
- G0399: Home Sleep Test, Type III Portable
- G0400: Home Sleep Test, Type IV Portable
- 95800: Sleep Study, Unattended
- 95801: Sleep Study, Unattended with Analysis
- 95806: Sleep Study (Vent-Resp-ECG-O2 Sat, Unattended)

Attended Sleep Studies:

- 95782: Polysomnography; Younger Than 6 Years, Sleep Staging With 4 Or More Additional Parameters of Sleep, Attended by A Technologist
- 95783: Polysomnography; Younger Than 6 Years, Sleep Staging With 4 Or More Additional Parameters of Sleep, With Initiation of Continuous Positive Airway Pressure Therapy or Bi-Level Ventilation, Attended by A Technologist

Prior authorization for the following codes will only be required for members 18 and older:

Attended/Facility Sleep Studies:

- 95805: Multiple Sleep Latency Test,
- 95807: Sleep Study (Vent-Resp-ECG-O2 Sat, attended by technician),
- 95808: Polysomnogram, 1-3+ parameters
- 95810: Polysomnogram, 4+ parameters
- 95811: Polysomnogram, CPAP, 4+ parameters

Other/Additional Code:

- 95803 Actigraphy Testing, Recording, Analysis, Interpretation, and Report (Minimum of 72 Hours to 14 Consecutive Days of Recording)
